

Guidelines for In-Person Visitation with St. Monica's Community Members Updated 4/7/2021

Please note that these guidelines are in place to protect our community members and prevent the spread of COVID-19. According to Wisconsin Department of Health Services guidelines, if community case positivity is low and St. Monica's is not in "Outbreak Status" (1 case or more of Covid-19), then visitation should be permitted.

Visit Guidelines

* All visitors must check in at the front desk to be screened prior to entry.

* All visitors must have an attestation form on file or complete one upon entry.

* Visitors will be permitted to visit in community member's room, outdoors or Connection Café only. Guests should go directly to the visit location and not stop in any other area along the way; this applies to arriving and leaving.

* No food or drinks will be allowed. The visitor may bring snacks/food for the community member but should refrain from eating/drinking during the visit.

* Facemask must be worn at all times by both visitor(s) and community member. (children under 2 years old do not have to mask indoors or outdoors)

* Maintain social distancing (6ft apart) unless pushing your loved one in a wheelchair outdoors.

* Only 3 adult visitors maximum per visit.

* Visitors under the age of twelve (12) must be accompanied by an adult. Visits are a maximum of 1 hour long. Visitors under the age of twelve (12) are not permitted in Oak Lane Memory Care at this time.

*Pets are welcome if potty-trained, up to date on vaccinations, leashed and restrained.

* Non-compliance with visitation rules may result in future visits being restricted.

Scheduling:

* All Memory Care visitors must call Michelle in advance at 262-631-3020 ext 254

* All Assisted Living Connection Café visits need to be scheduled at least 24 hours in advance. To schedule a visit, please call or text 262-822-8209.

* Preferred visiting hours will be daily between 9:00 a.m. - 5:00 p.m. If visiting outside of those times, please call in advance of your visit. Assisted Living 262-639-5050 opt.2 or Memory Care 262-631-3020 ext 254

COVID-19 Prevention and Precautions

* For the safety of your loved one, all visitors need to be screened and will not be allowed to visit if the answer is "yes" to any **ONE** of the following questions:

- Are you experiencing any loss of sense of smell/taste or loss of appetite?
- Are you experiencing any signs or symptoms of a respiratory infection such as a fever, dry cough, shortness of breath, runny nose, fatigue, congestion or sore throat?
- In the last 14 days have you had contact with someone with a confirmed diagnosis or is currently under the investigation for COVID-19 virus?

* The screener will take visitor's temperature. If temperature is greater than 99.6, visitor will not be allowed to visit.

* All visitors and community members must wear face masks at all times. **Visitors are asked to provide their own masks**. Cloth face masks are acceptable. The face mask must cover both the mouth and nose at all times.

* Please let St. Monica's know immediately if you develop symptoms after your visit.

* If St. Monica's should have a staff member or community member that tests positive for COVID-19, all visitation will be cancelled for at least 14 days or 14 days after there are no additional positive COVID-19 cases, whichever is greater.

* St. Monica's reserves the right to modify or cancel visitations at any time based on criteria such as an increase in community-wide (Racine County) spread, guidelines from CDC and the Department of Health Services, as well as other factors.

* Failing to follow the guidelines set forth may result in the loss of visitation privileges.

Memory Care Check-in Procedure:

* Visitors for Memory Care will come to the main door of the Assisted Living and be screened at the screening desk. Approved visitor(s) will then proceed through the building to the memory care.

* Please ring the doorbell at the Memory Care entrance and a staff member will let you in. Visitor(s) will be directed to the designated visit station or your loved one's room. Walking around the Oak Lane neighborhood or into community member rooms is strictly prohibited.
